 The Chairman, Ministry Procurement Committee, Ministry of Youth and Sports now invites sealed technical and price proposals (Design & Build) from joint venture of eligible and qualified Synthetic Track manufacturer (Full PUR) with local contractor for the Design, Construction and Laying of 130m - 4 Lane full PUR Synthetic training track facility for two Schools and three Sports Complexes

Two schools and three sports complexes are namely;

- A. Anuradhapura Central College, Anuradhapura
- B. D.S Senanayake College, Ampara
- C. District Sports Complex, Kotawila, Kamburugamuwa, Matara
- D. Sabaragamuwa Provisional Level Sports Complex, Ratnapura
- E. Sirimavo Bandaranayake Sports Complex, Gampaha

The project scope includes design and laying of 4 lane, 130m Full PUR (Polyurethane) Cast Elastomers Synthetic training track and Long and Triple Jump facility with a Full PUR synthetic runaway. The major items of Work consists of design and installation of foundation base including sub base and sub grade; design and installation of new drainage system, installation of full PUR 4 lane synthetic 130m track, class I tests for synthetic track, construction of Long and Triple Jump facility with a Full PUR synthetic runaway and maintain until the completion of Defects Notification Period, Installation of general purpose lighting, Chain-link fence and Landscaping work.

The Time for Completion for the whole of the Works shall be 150 calendar Days.

- 2. Bidding will be conducted through National Competitive Bidding Procedure
- 3. The eligible Bidders shall comply with the following qualification criteria.
 - a. Synthetic track manufacturer shall have experience in installing minimum number of ten (10) IAAF class II or IAAF class I or both, In situ (full PUR) tracks.
 - b. Synthetic track manufacture shall have IAAF certification of Full PUR track product with minimum of 13mm or above thickness
 - c. Synthetic track manufacturer shall have minimum of ten (10) years experience in the field of synthetic track manufacturing in full PUR system
 - d. The local contractor (partner in charge of the joint venture) shall have ten (10) years' experience in road construction.
 - e. Partner in charge of the joint venture shall be the Local Partner.

- f. Local partner of the joint venture shall have Construction Industry Development Authority (CIDA) (Former Institute of Construction Training And Development (ICTAD)) registration grade C2 or above for highway construction. Local partner shall participate to the Bid as joint venture with synthetic track manufacture (Full PUR).
- g. Joint venture agreement shall be attested by an authorized person (Attorney at Law or Notary Public) at the time of Bidding; and joint venture shall be register at Register General's Department after awarding the Contract and before the commencement of the Works.
- h. Synthetic track manufacturer (Full PUR) and local partner shall not have been blacklisted and local partner shall have valid registration during the bid validity period under CIDA.
- Average annual turnover of Construction Work performed during the last seven years shall be at least Sri Lankan Rupees 368 Million.
- j. The minimum amount of liquid assets and/or credit facilities net other contractual commitments and exclusive of any advance payments which may be made under this Contract shall be not less than Sri Lankan Rupees 147 Million.
- k. The Bidder should possess a valid certificate issued by the Registrar of Public Contract in accordance with the section 8 of Public Contracts Act No. 03 of 1987. To be submitted with Bid document and upon the recipient of the letter of intent.
- 1. The Foreign party to the joint venture shall obtain "temporary registration of foreign contractors" as per the sub section 39 (1) of the Construction Industry Development Act, No.33 of 2014; 0.01% of the contract value of the project is considered as fees for temporary registration, as given under instructions by the CIDA.
