Applications are called for the recruitment of an Attorney-at-Law on temporary basis for the post of Legal Officer of the Ministry of Sports and Youth Affairs.

Required Qualifications

(i) **Educational Qualifications/ Professional Qualifications :**

Should obtain a Degree in Law (LLB) of a University recognized by the University Grants Commission/ taking oaths as an Attorney-at-Law of the Supreme Court of Sri Lanka.

(ii) **Experience :**

Should have an active professional experience not less than three(03) years after taking oaths as an Attorney-at-Law.

(iii) **Physical Qualifications :**

Should be physically and mentally fit to serve and perform duties of the post.

(iv) **Other :**

Applicant should be a citizen in Sri Lanka with an excellent character.

(v) **Age Limit:**

The age of the applicants should not less than 21 years and not more than 45 years as at the closing date of the application.

Applicant's signature placed in the application shall be attested by a principal of a government school/ Justice of Peace/ Commissioner of Oaths/Attorney at Law/ Notary public/A Commissioned Officer of the Army, Navy or Air Force or an officer holding a permanent post in public service, earning a monthly consolidated salary of Rs. 47,615/-

Monthly payment of Rs. 47,615/= with the cost of living allowance which is entitled for the public servants will be paid for the selected officer. Secretary to the Ministry may terminate the service at any circumstance which he decided.
